

City of Centerville City Council Meeting on October 9, 2024

The Centerville City Council met for their regular monthly meeting on Wednesday, October 9, 2024 at 7:00 p.m. in the Municipal Building Meeting Room. Council members present were Michael Cannain, Charlie Shafer, Bobby Walters, Rebecca Smith and Wendy Baldwin. Mayor Noal Ray Goolsby called the meeting to order at 7:00 p.m. and a quorum was established.

Bobby Walters made a motion to approve the September 4, 2024 regular meeting minutes as presented. Charlie Shafer gave the second to this motion. Motion carried 5 ayes 0 noes and 0 absent

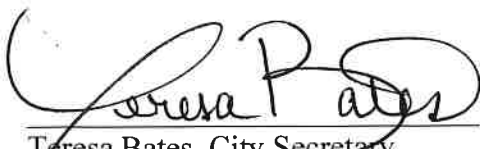

There was a short discussion in regards to the Hotel/Motel Occupancy Tax Recipients. Wendy Baldwin delivered the first motion requesting to leave these as they currently are for the 2024/2025 Fiscal Year. These include Centerville Chamber of Commerce - receiving quarterly .375% of H/M Occupancy Tax collected; July Fourth Committee - receiving quarterly .375% of H/M Occupancy Tax collected; and, Leon County Expo Center - receiving quarterly .25% of H/M Occupancy Tax collected. Rebecca Smith provided a second motion. Motion carried 5 ayes 0 noes and 0 absent

Motion to approve employee time sheets for the month of September 2024 was furnished by Michael Cannain. Second to this motion came from Charlie Shafer. Motion carried 5 ayes 0 noes and 0 absent

Motion to pay the bills was first given by Wendy Baldwin and was then seconded by Michael Cannain. Motion carried 5 ayes 0 noes and 0 absent

Motion to adjourn at 7:42 p.m. was given by Wendy Baldwin and seconded by Rebecca Smith. Motion carried 5 ayes 0 noes and 0 absent
