

City of Centerville City Council Meeting on March 5, 2025

The Centerville City Council met for their regular monthly meeting on Wednesday, March 5, 2025 at 7:00 p.m. in the Municipal Building Meeting Room. Council members present were Charlie Shafer, Michael Cannain, Rebecca Smith, Wendy Baldwin and Bobby Walters. Mayor Noal Ray Goolsby called the meeting to order at 7:00 p.m. and a quorum was established.

Public Comments:

1. Charlie Shafer asked what the status was in regards to the large tree limb (from a tree in Robin Banfield's yard) laying on a cable wire that hangs over the road in front of Mrs. Banfield's house. If the limb breaks it could possibly cause the cable to fall onto a vehicle if one was traveling by at the time it fell. Mayor Goolsby said the City had called the electric company and TxDot to see what needed to be done and they both responded "the Banfield's were responsible for having the tree trimmed or removed because it was on their private property."
2. Bobby Walters asked if anyone knew who all the hay belonged to that is being stored at the corner of Rusk and East Church Street. Rebecca Smith said it belongs to her grandson, Chris Smith.

Michael Cannain made a motion to approve the February 5, 2025 regular meeting minutes as presented. Charlie Shafer gave the second to this motion. Motion carried 5 ayes 0 noes and 0 absent

Charlie Shafer raised the first motion to approve **Financial Management Policies & Procedures** for the American Rescue Plan Act Grant Project. Wendy Baldwin offered a second motion. Motion carried 5 ayes 0 noes and 0 absent

Wendy Baldwin volunteered the first motion approving an Atmos Cities Steering Committee Resolution and authorizing payment of five cents (.05) per capita; (905 X .05 = \$45.25) Charlie Shafer supported a second motion. Motion carried 5 ayes 0 noes and 0 absent

Charlie Shafer opened with the first motion approving Daniel Shirley (Public Works Director) to purchase a new City work truck from Bill Fick Ford in Huntsville, Texas. Rebecca Smith brought a second motion. Motion carried 5 ayes 0 noes and 0 absent

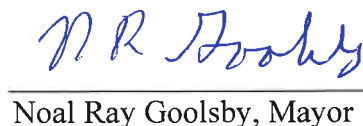
