

City of Centerville City Council Meeting on April 9, 2025

The Centerville City Council met for their regular monthly meeting on Wednesday, April 9, 2025 at 7:00 p.m. in the Municipal Building Meeting Room. Council members present were Charlie Shafer, Michael Cannain, Rebecca Smith, Wendy Baldwin and Bobby Walters. Mayor Noal Ray Goolsby called the meeting to order at 7:00 p.m. and a quorum was established.

Public Comments: Daniel Shirley explained how the old fire station building (that was recently renovated by the Centerville EDC) was inspected after someone requested this be done, and is not ADA compliant. There are a lot of changes that will need to be made and this could become quite costly for the City. *Please see the attached document listing all violations that have been noted.

Wendy Baldwin made a motion to approve the March 5, 2025 regular meeting minutes as presented. Michael Cannain gave the second to this motion. Motion carried 5 ayes 0 noes and 0 absent

Bobby Walters raised the first motion approving the city's Personnel Policy Manual be edited to say all full-time employees hired after April 9, 2025 will be eligible to carry over only 250 unused vacation hours a year vs. the 950 hours current full-time employees can carry from year to year. A second motion came from Wendy Baldwin. Motion carried 5 ayes 0 noes and 0 absent

Banza Langford's city truck (2016 Dodge Ram) was discussed. It has been in the repair shop a lot the last couple of years. It has already had a new motor installed. The mechanic that works on the truck told Daniel Shirley the truck is not in good condition and will continue to need repairs and he recommends getting rid of it if possible. No action was taken at this time.

There was discussion only in regards to having some clean-up work done on North Cass Street. Mayor Goolsby said he had already spoken with Brice Bell about taking care of this.

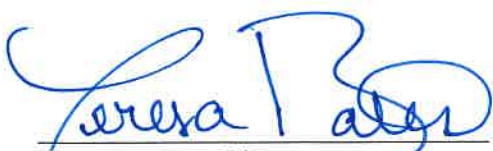
The FLOCK digital license plate reading system was discussed. This was approved at an earlier meeting therefore no action was taken.
