

City of Centerville City Council Meeting on November 5, 2025

The Centerville City Council met for their regular monthly meeting on Wednesday, November 5, 2025 at 6:00 p.m. in the Municipal Building Meeting Room. Council members present were Michael Cannain, Charlie Shafer, Bobby Walters and Rebecca Smith and Sue Sandel. Mayor Noal Ray Goolsby, called the meeting to order at 6:00 p.m. and a quorum was established.

Public Comments: Sue Sandel inquired on where Daniel Shirley was in regards to the sagging ceiling in the City Hall Meeting Room. Daniel told her he had made arrangements with an engineer (to be here in November 2025) to come peel back some of the walls and ceiling in the meeting room in order to assess the damage more effectively. He said he would update the Mayor and City Council once he received the engineer's report.

Charlie Shafer made a motion to approve the October 8, 2025 regular meeting minutes as presented. Michael Cannain gave the second to this motion. Motion carried 5 ayes 0 noes and 0 absent

Charlie Shafer moved with the first motion approving a Resolution adopting the FEMA approved Leon County Multi-Jurisdiction Hazard Mitigation Plan. Bobby Walters added a second motion. Motion carried 5 ayes 0 noes 0 absent

Clint Franklin (Centerville EDC board president) was in attendance to discuss moving forward with getting the old fire station building ADA compliant. Charlie Shafer offered the first motion approving the Centerville Economic Development Corporation (EDC) to look into what it would take to get this project done. Bobby Walters would like to see someone from the EDC or the City get some Bids from ADA compliant knowledgeable people in order to have an idea of how much money would be needed for this task. Engineering Bids will also be needed. Sue Sandel supplied a second motion. Motion carried 5 ayes 0 noes 0 absent

Sue Sandel granted the first motion approving the City to keep the Leon County Expo's portion (.25 %) of the Hotel/Motel Occupancy Tax money collected quarterly. Rebecca Smith followed with a second motion. Motion carried 5 ayes 0 noes 0 absent

Motion to approve employee time sheets for the month of October 2025 was furnished by Charlie Shafer. Second to this motion came from Michael Cannain. Motion carried 5 ayes 0 noes and 0 absent

Motion to pay the bills was first given by Charlie Shafer and was then seconded by Rebecca Smith. Motion carried 5 ayes 0 noes and 0 absent

Motion to adjourn at 6:17 p.m. was given by Charlie Shafer and was seconded by Sue Sandel. Motion carried 5 ayes 0 noes and 0 absent
