

City of Centerville City Council Meeting on December 3, 2025

The Centerville City Council met for their regular monthly meeting on Wednesday, December 3, 2025 at 6:00 p.m. in the Municipal Building Meeting Room. Council members present were Michael Cannain, Charlie Shafer, Bobby Walters and Rebecca Smith and Sue Sandel. Mayor Noal Ray Goolsby, called the meeting to order at 6:00 p.m. and a quorum was established.

Public Comments: Michael Cannain wanted to express how pleased he was to see the tree removed on South Cass Street. Its dead limbs had been hanging over the road.

Charlie Shafer made a motion to approve the November 5, 2025 regular meeting minutes as presented. Michael Cannain gave the second to this motion. Motion carried 5 ayes 0 noes and 0 absent

Charlie Shafer moved with the first motion approving Bleyl Engineering's recommendation letter to award a Construction Contract for TxCDBG CDV23-0060 to D&M Tank, LLC in the amount of \$401,670.00. This grant will include Water Tower Restorations but will not involve painting the decal on the City Water Tower. The City will be responsible for funding this part of the project. A second motion came from Michael Cannain. Motion carried 5 ayes 0 noes 0 absent

Virginia Free, Caroline Lummus and Charlie Lummus were in attendance to discuss commercial and residential burning within the Centerville city limits. These citizens mentioned, have recently had a fire (due to commercial burning of down trees) get out of control and come very close to reaching their property/homes. They would like the Mayor and City Council to approve/adopt an Ordinance prohibiting any type of burning inside the Centerville city limits. The city attorney will be contacted in order to move forward with this request. No action was taken at this time.


There was discussion only in regards to having future City Council Meetings livestreamed. No one seemed to be in favor of this proposal. No action was taken at this time.
