


**City of Centerville Special Called Meeting on May 12, 2026**

## City of Centerville City Council Meeting on May 6, 2026

The Centerville City Council met for their regular monthly meeting on Wednesday, May 6, 2026 at 6:00 p.m. in the Municipal Building Meeting Room. Council members present were Charlie Shafer, Michael Cannain, Bobby Walters and Brian Jones. Rebecca Smith was not in attendance. Mayor Noal Ray Goolsby called the meeting to order at 6:00 p.m. and a quorum was established.

### Public Comments:

1. Charlie Shafer expressed that he would like Daniel Shirley (Public Works Director) to look at the manhole on Church/Town Street. The manhole seems to be sitting up too high off the ground and could possibly be damaged if changes aren't made to it.

Charlie Shafer made a motion to approve the April 8, 2026 regular meeting minutes as presented. Brian Jones gave the second to this motion. Motion carried 4 ayes 0 noes and 1 absent

(Charlie has also spoke to Phillip Mullen in regards to having the cable cleaned up) Brian Jones volunteered a second motion. Motion carried 4 ayes 0 noes and 1 absent

Charlie Shafer supplied the first motion agreeing to set May 12, 2026 at 5:30 p.m. as the date and time for a special called meeting for approval of the Canvass Returns and to declare Official Results of the May 2, 2026 City Election. Bobby Walters replied with the second motion. Motion carried 4 ayes 0 noes and 1 absent

Motion to approve employee time sheets for the month of April 2026 came from Michael Cannain. Charlie Shafer agreed to a second motion. Motion carried 4 ayes 0 noes and 1 absent

Motion to pay the bills was first given by Charlie Shafer and was then seconded by Michael Cannain. Motion carried 4 ayes 0 noes and 1 absent
